**The cost of the camp is £100 per child per week for the morning or afternoon sessions or £190 per week for the all day session**

**For the first Easter week which is a 4 day week due to the bank holiday the cost of the morning or afternoon sessions is £80 and the all day sessions £150**

We will be opening during the Easter holidays and the first 5 weeks of the Summer holidays, and whilst we will be offering a range of activities similar to those offered in the past, the structure of the camp will be more flexible and the activities will be driven by the interests of the children. We will still offer a mixtures of activities such as sport, art/craft/pottery, dance, drama, lego building, slime making, tug of war and even water play when weather permits... There will be a morning and an afternoon session each day and the children will be able to select their activities for each session every day. Opportunity for free play will be set up throughout the day. More structured adult led activities will be organised throughout the day and children will be able to take part as often as they wish.

The timing of the day is as follows, the two sessions are:

Morning session 8:30am to 12:45pm (Children will have supervised free play until the activities start at 9:00am)

Afternoon session 1:00pm to 5:00pm and of course all day from 8:30am to 5:00pm

Morning break 10:00 to 10:30      Afternoon break 2:30 to 3:00      Lunch 12:00 to 12:45

You may secure a place by transferring the full amount or a deposit of £50 per child.

There is a 10% discount for brothers or sisters attending together or for children who currently attend a Freedom After School Club. A non-refundable deposit of £50 per child is required when booking places.

## Terms and conditions

### Data Protection

The information collected on this form will be held by Freedom Activity Camp in manual and in electronic format. The information will be processed in accordance with the Data Protection (Jersey) Law 2018. The purpose of holding this information is to facilitate your child's participation with Freedom Activity Camp. Disclosure of any of this information to statutory bodies such as the Department for Education or its agencies will take place only in accordance with legislation or regulatory requirements. Explicit consent will be sought from Parents/Guardians if Freedom Activity Camp wishes to disclose this information to a third party for any other reason.

### Registration of Camp

Freedom Activity Camp is a registered play care provider and parents may be able to claim a tax allowance for the fees paid to us for all of our activity camps.

### Exclusion after sickness

If your child is unwell at home with sickness and/or diarrhea, they should be kept at home for a **minimum of 48 hours following the last episode of illness**. If they are sick and/or have diarrhea at the club, there must be a minimum period of 48 hours following the last episode before they return.

### Signing out

Each child must be signed out at the end of each session, by a member of *our* staff. Please make sure that you have signed your child out before you take them home. We will not allow your child to leave with any person not named on the registration form.

Each booking must be accompanied by a non refundable deposit of £50 per child. if you wish, you may pay the whole fee at the time of booking. Cancellation prior to seven days in advance of the first day of the booked week will incur no penalty and any money paid other than the deposit will be refunded. Cancellation after seven days **or a no show** will be charged the full amount due for the time booked.

I consent to my child taking part in the Freedom Activity Camp. I understand that whilst every precaution will be taken to ensure the safe participation of all participants, the organisers cannot be responsible for injuries, illness, accidents, theft or loss. In the event of the camp being cancelled on the part of the organisers a full refund will be made.
